077	Declaration of Interest under the Code of Conduct No declarations, under the Code of Conduct were made at this stage of the meeting.
078	Minutes of the Previous Meeting The minutes of the meeting held on the 2 <sup>nd</sup> July 2024, having been previously circulated, were adopted as a true record and were signed by the chairman
079	Matters Arising from the Minutes Following concerns raised at the July meeting by a parishioner the Thorncombe Environmental Group had issued a report highlighting what they intended to undertaken in respect of the cemetery area. Members were satisfied with these proposed arrangements.
